Matt Miller, Project Manager for the Johnson County Access Center provided information on the project. The facility will be used as an urgent care for individuals in a behavioral health or substance abuse crisis. Bids for the project will be in July 2019 with construction beginning in September, 2019. Grand Opening is anticipated to be in October 2020. The estimated start up cost is 9.1 million with 8.4 million secured so far. Miller is requesting support from all municipalities in Johnson County.

Resolution 2019-09 was presented authorizing signatory for Hills Bank & Trust Investment accounts. A motion was made by Knebel and seconded by Peters to approve Resolution 2019-09. Roll Call: Ayes: Knebel, Peters, Harris, Hill, Volk. Resolution 2019-09 approved.
